

# **Privacy Policy**

## **Our Commitment To Privacy:**

Your privacy is important to us. To better protect your privacy we provide this notice explaining our online information practices and the choices you can make about the information we have collected. *US Insurance Zone* is committed to protecting all personal information. All of the information we gather will be limited to our use only. We do not provide information to any person or entity other than the Producer or their authorized representatives.

## **The Personal/Agency Information We Collect:**

The information we gather during registration is used solely for the purpose of establishing and managing your account. We only collect the information necessary to conduct business with the Producer and to protect their access to our website. When you register on our website you agree to receive informational updates on any new services that we offer.

## **Our Commitment To Secure Data:**

To prevent unauthorized access, maintain data accuracy, and ensure the correct use of information, we have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect online.

## **How You Can Access or Correct Your Information:**

When a Producer registers on our site, we use their sign-in information, which contains personally identifiable information, to ensure that only the Producer or their representative who has signed in has access to his or her personal areas of the site. To protect your privacy and security, we will also take reasonable steps to verify your identity before granting access or making corrections. You can access the information we collect online by logging into your lead manager panel. This procedure better safeguards your information. You can personally edit your profile and credit card information in your lead manager panel. To amend, update, or verify the information on file that does not have user fields, send a request by e-mail, fax or US Mail and we will acknowledge your request when the information has been reviewed. We are unable to make changes without a written request.

## **Billing Details:**

Under the Fair Credit Billing Act, your bank cannot hold you liable for more than \$50 of unauthorized charges. Note that, in the event of unauthorized use of your credit card, you must notify your credit card provider in accordance with its reporting rules and procedures. Notify us as soon as possible to avoid any further unauthorized charges.

## **Security:**

*US Insurance Zone* makes every effort to ensure that any identifiable information that it receives via the internet is secure against unauthorized access. We use secure server software over a Secure Socket Layer (SSL) line to protect your credit card information. It encrypts all of your personal and credit card information so that this information cannot be read as it travels through our system. This means that no eyes but ours will ever see the information that our Producers send to us, unless we indicate otherwise. We will only give out personal information as required by law, for example to comply with a court order or subpoena or to assist in criminal investigations. We may also give out personal information when we deem it advisable in order to protect the safety and security of our sites. We do not monitor or control the content that appears on any possible linked sites and such content may be constantly changing. We encourage all end users to read the privacy policies of all linked sites before navigating through them.
